21.61.2 Eligible Services

This is an offering exclusively for new installations of DS1 service as provided in Section 21.61.3. The quantity and terms are provided in Section 21.61.5 following.

21.61.3 Serving Area

The serving areas for the DS1 route of this option are comprised of the Customer's POP served by the Moanalua wire center on one (1) end of the route and the Customer's POP serviced by the wire center located in Lahaina on the other end. All services that originate and terminate at End User locations are not covered under this Option.
