This contract is for a renewal of 116 DS1 circuits and 8 DS3 circuits which will be billed at the discounted monthly rate below. The monthly rates will be frozen from Company-initiated rate changes until December 31, 2013. Nonrecurring charges will not apply.

Discounted rates for DS1 and DS3:

- Monthly Recurring Rates \$79,579.00

The following eligibility criterion must be met in order to receive this contract offer.

- The DS1 and DS3 circuits must be existing.
- The customer must purchase an OC48 SHNS ring in combination with at least 8 DS3 circuits and 116 DS1 circuits.
- The SHNS ring must have a configuration of five nodes consisting of two hub nodes and three access nodes.
