Application for special permission requests waiver of the requirements of Section 61.74 of the Federal Communications Commission's Rules (FCC) in order to make reference in CenturyLink Operating Companies Tariff F.C.C. No. 9 Section 24, Contract No. 13-002, to the similar contract tariff of Qwest Corporation d/b/a CenturyLink QC (CenturyLink) Tariff F.C.C. No. 11, Contract No. 13-012.

Application is also being made on behalf of Qwest Corporation d/b/a CenturyLink QC for Special Permission to waive the requirements of § 61.74 of the Commission's rules in order to make reference in CenturyLink Operating Companies Tariff F.C.C. No. 11 Section 24, Contract No. 13-012 to the similar Contract Tariff of CenturyLink Operating Companies Tariff F.C.C. No. 9, Contract No. 13-002.

With this filing the CenturyLink Operating Companies are proposing to offer DS1 and DS3 Price Flex Contracts (No. 13-002 and No. 13-012), which require concurrent subscription to the CenturyLink Operating Companies Tariffs F.C.C. No. 9, Contract No. 13-002 and F.C.C No. 11, Contract No.13-012.

In this regard, the CenturyLink Operating Companies request permission to waive Section 61.74 of the Commission's rules in order to include the above mentioned tariff reference in its proposed contract tariff filing.

Illustrative tariff pages for Contract No. 13-002 and 13-012 are included with this application for CenturyLink Operating Companies Tariff F.C.C. No. 9 and Tariff F.C.C. No. 11.
