4. End User Access Service (Cont'd)4.10 Universal Service Fund (USF) Charge

The USF end user-charge is designed to recover all Telephone Company contributions to federally mandated universal support mechanisms. Federal USF end-user charges will not apply to end-users as described in 4.8 preceding.

The USF recovery charge is computed by first summing end-user monthly Interstate charges (End-User Common Line Charge, Access Recovery Charge, Presubscribed Interstate Carrier Change Charge, End-user special access, and interstate IntraLATA Toll charge). This sum is multiplied by the FCC's quarterly USF contribution factor, as set below to yield the end-user monthly USF charges.
