This filing proposes revisions on behalf of Skyline Telephone Membership Corporation ("Skyline"). The proposed revisions introduce rates for new transmission speeds under existing Ethernet Transport Service ("ETS") and DSL Wholesale Pricing Plan ("WPP") regulations. Revisions are also proposed to revise and expand the monthly volume commitment levels for the DSL WPP Volume Pricing Commitment Plan.

In addition, this filing proposes maintenance revisions for Millington Telephone Company, Inc. to reflect the trade name of "d/b/a Ritter Communications" throughout the tariff.
