- 1. The Customer agrees to pay additional costs if this request is altered or modified in any way, or if work is required to be performed other than during the Company's normal business hours, and such work is requested by the Customer. If any additional work is requested, a quote will be provided by the Company and no additional work will occur until a written agreement is reached as to the additional costs.
- 2. The Customer agrees that if additional unforeseen work is required, current work will stop until additional needs and costs are agreed upon. If the Customer chooses not to move forward, the Customer shall pay all actual, direct and verifiable costs incurred by the Company, including internal labor costs.
- 3. If the Customer terminates this service or cancels the agreement subsequent to execution but prior to completion of the Special Construction services, the Customer shall pay all costs incurred by the Company up to the date of termination by the Customer. Any such charges shall be due and payable in one lump sum within thirty (30) days of Customer's receipt of invoice.
