As part of this filing non-premium and transitional tariff information is also being removed from the tariffs since the CLOCs have converted all of their offices to Equal Access. Vintage rates that have expired are also being removed from the Switched Access Section of the tariff. And minor tariff language changes designed to clarify the provision of interstate service are being included in this filing.

In addition to the above changes, eight new special construction cases are being added in Tariff F.C.C. No. 12, Special Construction. Supporting information for these cases, discussed under Section 61.38 of the Commission's Rules, is included in the attached Special Construction Description and Justification (D&J).

In accordance with the requirements of Section 61.21(a)(3) of the Commission's Rules, the FCC Registration Number (FRN) for CenturyLink is 0018-6268-53. CenturyLink is filing this transmittal on behalf of issuing carriers on Attachment A.
