An Ethernet Virtual Private Line Term Discount Plan (TDP) is available for EVPL service and applies to UNI and NNI port connections, EVPL channel mileage, EVC connections, QoS, ICO NNI Trunking Arrangement and ICO NNI Additional Mileage. A TDP provides the customer discounted rates for the rate elements listed.

The customer has the option of ordering EVPL under a term commitment period of 1, 2, 3 or 5 years. The customer must notify the Telephone Company in writing the length of its selected term commitment period. In order for a circuit to be eligible for TDP pricing, the customer must commit a UNI and/or NNI port connection to a TDP.
