The CLOC is filing to update the universal service contribution factors for the second quarter of 2014. This update applies the factor as adopted in Public Notice DA 14-337, released March 12, 2014. Supporting information for these rates is included in the attached USF Description and Justification (D&J).

As part of this filing the CLOC also proposes to add fifty-three (53) new special construction cases in its Tariff F.C.C. Nos. 1, 5, 8 and 9 and fifteen (15) in Tariff F.C.C. No.12, Special Construction. Supporting information for these cases, discussed under Section 61.38 of the Commission's Rules, is included in the attached Special Construction Description and Justifications (D&J).

This filing also includes a change to CLOC Tariff F.C.C. No. 1 changing the Tandem Switching – Per Access Minute Per Tandem from an ICB to a zero rated originating and terminating element.
