5. Ordering Options for Switched and Special Access Service (Cont'd)5.2 Access Order

An Access Order is used by the Telephone Company to provide a customer Access Service as follows:

- Switched Access Services as set forth in 6, following,
- Special Access Services as set forth in 7, following,
- Other Services as set forth in 5.1.2, preceding, and
- TIPTOP Services as set forth in 24, following

If a PIU is required, the customer must provide its PIU when placing an order for Access Services in accordance with Section 2.3.14 of this tariff.

(A) The following applies when placing an order for all Switched Access Services:

- (1) When ordering an Entrance Facility, the customer shall specify: (T)
- (a) Whether DSO, DS1 or DS3.
 - (b) The multiplexing required for DS3 to DS1 or DS1 to DSO.
 - (c) Customer designated premises, hub, type of service, interface and technical specifications. (T)
- (2) When ordering Direct Trunked Transport, the customer shall specify: (T)
- (a) Whether DSO, DS1 or DS3.
 - (b) The multiplexing required for DS3 to DS1 or DS1 to DSO.
 - (c) Customer designated premises, hub, switch location (i.e., Access Tandem or End Office), type of service, interface and technical specifications. (T)
 - (d) The channel facility assignment when Direct Trunked Transport is interconnected with an existing Entrance Facility. (T)
 - (e) The number of trunks. (T)
- (3) When ordering Tandem Switched Transport, the customer shall specify: (N)
- (a) The number of trunks.
 - (b) The Access Tandem location.
 - (c) Switched Transport options and Local Switching options
 - (d) Customer designated premises, types of service, interface and technical specifications.
 - (e) The channel facility assignment when Tandem Switched Transport is interconnected with an existing Entrance Facility. (N)
