CenturyLink Communications, LLC Tariffs F.C.C. Nos. 1, 2, 3, 4 and 5 are being filed to reflect the consolidation of multiple CenturyLink owned companies into one company called CenturyLink Communications, LLC. On the effective date, these tariffs will replace the existing CenturyTel Acquisition, LLC F.C.C. No. 1, CenturyTel Solutions, LLC F.C.C. No. 1, Embarq Communications, Inc F.C.C. No. 1, Madison River Communications, LLC F.C.C. No. 1 and Qwest Communications Company, LLC F.C.C. No. 1 which are being cancelled by Supplements. The regulations, rates and charges contained in CLC Tariffs F.C.C. Nos. 1, 2, 3, 4 and 5 are identical to those found in the current Tariffs with the exception of minor textual changes necessary to reflect the revised page numbers and ensure consistent heading and references.

As part of this filing CenturyLink is also changing the name of its Qwest Communications Company, LLC d/b/a CenturyLink QCC Interstate Operator Services Informational Tariff to CenturyLink Communications, LLC and cancelling its Qwest LD Corp. d/b/a CenturyLink LD Interstate Operator Services Informational Tariff.

CenturyLink Communications, LLC Tariffs F.C.C. No. 4 is being filed to reflect a decrease to the Local Switching rate in order to mirror the RBOC rate in that region. CenturyLink Communications is also proposing to increase the Federal Universal Service Fund Charge in its Tariff F.C.C. No. 5 and its Informational Tariff.
