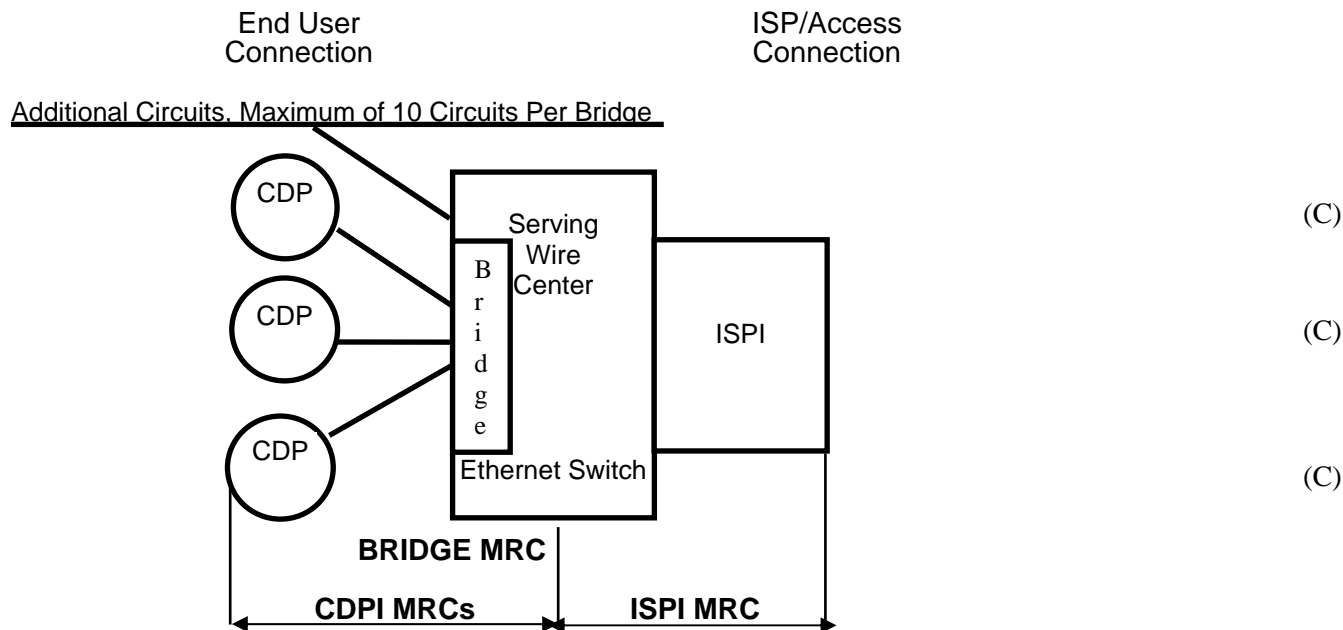
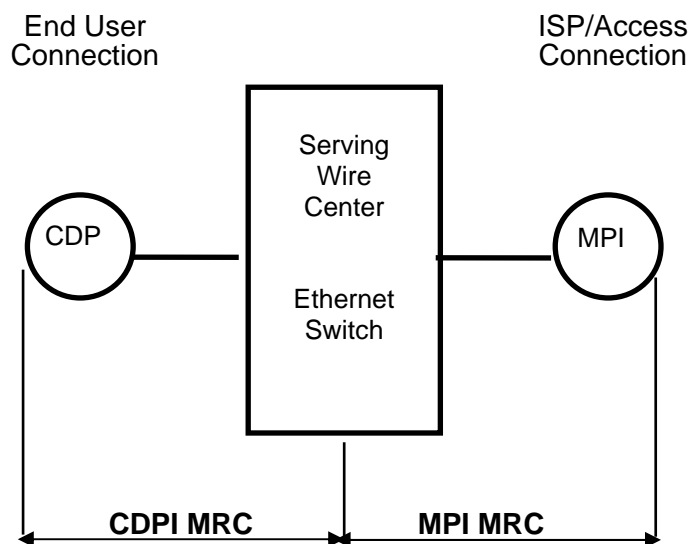

The METS Fixed Rate Option (FRO) Plan 3 allows customers to freeze the rates in effect as of May 31, 2014 for either a 36-month or 60-month period corresponding with, respectively, a three-year or five-year term commitment. Customers may elect METS FRO Plan 3 anytime between May 31, 2014 and June 30, 2014. After June 30, 2014, FRO Plan 3 will not be available for new or added services. The frozen rates for METS FRO Plan 3 are listed herein in Section 17.4.8.4(G) following and will be billed in lieu of rates listed in Section 17.4.8.4(A) until the termination of the applicable term commitment period. Customers may elect METS FRO Plan 3 anytime between May 31, 2014 and June 30, 2014. After June 30, 2014, FRO Plan 3 will not be available for new or added services. The frozen rates for METS FRO Plan 3 are listed herein in Section 17.4.8.4(G) following and will be billed in lieu of rates listed in Section 17.4.8.4(A) until the termination of the applicable term commitment period. The regulations for the METS FRO Plan are contained at Section 16.5.3(F)(4) preceding. The regulations applicable to METS Term Discount Plans are contained in Section 16.5.3(F) preceding.
