Dear Ms. Dortch:

Attached for submission to the Commission are revised sheets 2 and 90.2 to Granite Telecommunications, LLC (“Granite”) Switched Exchange Access Services Tariff, FCC Tariff No. 1, for incorporation into the Company’s Tariff.

This submission is made pursuant to the Commission’s *Report and Order and Further Notice of Proposed Rulemaking*, in Docket Nos. WC Docket No. 10-90, et al., FCC 11-161,¹ *Second Order on Reconsideration* in Docket Nos. WC Docket No. 10-90, et al., FCC 12-47,² and Section 51.911 of the FCC’s rules, 47 C.F.R. §51.911.

Granite complies with the above cited orders and rule by reducing its terminating intrastate end office rate element by a third of the difference between its current end office rate element and \$0.0007 applicable to underlying price cap incumbent local exchange carriers per Section 51.907 of the FCC’s rules, 47 C.F.R. §51.907. This reduction also applies to the Company’s interstate terminating switched access and Voice over Internet Protocol – Public Switched Telephone Network rates. This amendment becomes effective on July 1, 2014.


