The following Tariff revisions are being made:

- (1) Changes to the Additional Mileage ICO NNI to exclude the EVPL High Volume Discount Plan from this rate. Corresponding rate reductions to the EVPL ICO NNI High Volume Discount Plan were filed on June 16, 2014 in CenturyLink Operating Companies F.C.C. Annual Price Cap filing Transmittal No. 56. (Tariff F.C.C. Nos 1, 2, 3, 6, 7, 8, and 9).
- (2) Changes to add additional speeds (600, 800 and 900 Mb) to the EVPL EVC and Quality of Service elements. (Tariff F.C.C. Nos. 1, 2, 3, 6, 7, 8, and 9)

- (3) Changes to tariff language in its CenturyLink Operating Companies Tariff F.C.C. No. 11 to eliminate the requirement that customers must initially purchase DS3 Service Channel Terminations under a Fixed Pricing Plan of 12-, 24-, 36-, 60-months before converting to month to month.
- (4) CenturyLink is adding twelve new special construction cases in its Tariff F.C.C. No. 12, Special Construction. Supporting information for these cases, discussed under Section 61.38 of the Commission's Rules, is included in the attached Special Construction Description and Justification (D&J).

In accordance with the requirements of Section 61.21(a)(3) of the Commission's Rules, the FCC Registration Number (FRN) for CenturyLink is 0018-6268-53. CenturyLink is filing this transmittal on behalf of issuing carriers on Attachment A:
