Re: 2014 ANNUAL ACCESS TARIFF

Dear Ms. Dortch:

The accompanying tariff issued by Union Telephone Company (Union) (FRN #0001-6302-01) bearing F.C.C. No. 2, effective July 1, 2014, is sent to you in compliance with the Communications Act of 1934, as amended and pursuant to the Commission's Rules.

The purpose of the filed tariff materials is to make several changes in Union's interstate switched access rates, as well as to modify its access recovery charges (ARCs). Union is a Subset 3 carrier with 50,000 or fewer access lines and, therefore, is submitting this filing pursuant to Section 61.39 of the Commission's rules.

Whereas Union normally would not be required to make a Section 61.39 filing this year, it is submitting this transmittal pursuant to the requirement that rate-of-return incumbent local exchange carriers must file a Tariff Review Plan (TRP) this year to comply with the requirements of sections 51.909(d), 51.917(d)(iii) and 51.917(e) of the Commission's rules. This tariff filing is also accompanied by the certifications required by Sections 54.304(d) and 51.917(f) of the Commission's Rules.



By this filing, Union reiterates and reaffirms its previous election to receive Connect America Fund Intercarrier Compensation (CAF ICC) support under Section 51.917 of the Commission's Rules, and to tariff an Access Recovery Charge in certain of its exchanges pursuant to the Commission's rules.
