The Verizon Telephone Companies (Verizon) hereby apply for Special Permission for a waiver of Section 61.74 of the Commission's rules, 47 C.F.R. § 61.74.

Verizon intends to introduce a new contract tariff option in its Access Service Tariff FCC No. 1 (FCC1), Access Service Tariff FCC No. 11 (FCC11), and Facilities for Interstate Access Tariff FCC No. 14 (FCC14). The new contract tariff option provides billing credits for certain access services when the customer meets conditions as further described in the new contract tariff option.

Verizon requests special permission to waive the requirements of Section 61.74 of the Commission's rules in order to allow FCC1, FCC11, and FCC14 to make the following references to each other and to Tariff FCC No. 16 (FCC16):

- \* FCC1, FCC11, and FCC14 must reference each other and FCC16 for the purpose of restricting the customer from subscribing to any alternative tariff arrangement.
- \* FCC1, FCC11 and FCC 14 must reference each other for the purpose of defining a termination or withdrawal of the contract tariff option in the event of a regulatory change.

- \* FCC1, FCC11, and FCC14 must reference each other and FCC16 for the purpose of identifying the special access DS1 services and special access DS3 services included in this new contract tariff option and the section numbers where the regulations for such services are found.
- \* FCC1, FCC11 and FCC14 must reference each other and FCC16 for the purpose of identifying the tariffed discount or term plans to which the customer must be subscribed in order to be eligible for the new contract tariff option.
- \* FCC1, FCC11, and FCC14 must reference each other for the purpose of specifying that the customer's subscription to, or termination of, the contract tariff option in one of the tariffs shall be an automatic subscription to, or termination of, the contract tariff option in the other tariffs.
- \* FCC1, FCC11, and FCC14 must reference each other for the purpose of defining the Metropolitan Statistical Areas that comprise the Serving Area for the new contract tariff option and in which Billing Credits apply.
- \* FCC1, FCC11 and FCC14 must reference FCC16 for the purpose of stating that no credits will be provided under that tariff.
- \* FCC1, FCC11, and FCC14 must reference each other for the purpose of identifying certain pricing plans, the suspension of true-ups under such plans during the service period of the new contract tariff option, and the resetting of the commitment levels for such plans at the end of the service period.
- \* FCC1, FCC11, and FCC14 must reference FCC16 for the purpose of excluding dispute terms specific to the new contract tariff option for services provided under that tariff.

This application and associated attachments are being filed electronically today via the Federal Communications Commission's Electronic Tariff Filing System (ETFS).
