3. SERVICE AND RATE DESCRIPTION (Continued)

3.2 Sprint Standard Weekends

Sprint Standard Weekends service is available to any residential customer who contacts Sprint or is contacted by Sprint and requests this service plan, or who subscribes through the local telephone company. Customer may subscribe to another Sprint residential service by contacting Sprint or a Sprint representative.

(1). Interstate Service

All calls are billed in whole minute increments. Partial minutes are rounded up to the next whole minute.

Customers who subscribe to Sprint Standard Weekend will be assessed a \$5.95 monthly recurring charge.

(1). Dial-1 Per Minute Rates

The following per minute rates apply for calls originating from the U.S. Mainland, Hawaii, Puerto Rico and the U.S. Virgin Islands and terminating to Alaska, the U.S. Mainland, Hawaii, Puerto Rico and the U.S. Virgin Islands:

All Hours Monday-Friday	\$0.40
All Hours Saturday	\$0.25
All Hours Sunday	\$0.10

(2). Operator Services Per Minute Rate and Call Placement Charges

The interstate per minute rate for operator service is \$0.89. The applicable Call placement charge below will apply in addition to the per minute rate. The Operator Dialed Surcharge applies to calls when the Customer has the ability to dial all the digits necessary for call completion but dials instead 0 or 00 to reach the Sprint operator, to 0+ calls originating from local exchange offices which do not have international direct dialing service capability, and to 0+ calls terminating in countries where direct dial equipment is unavailable.
