This filing includes the following revisions to the applicable tariffs as indicated:

- (1) Proposes the increase to the Ethernet virtual Private Line channel mileage free allowance from 30 to 45 miles. (Tariff F.C.C. Nos 1, 2, 3, 6, 7, 8, and 9).
- (2) Changes to language to add additional speeds (600, 800 and 900 Mb) to the EVPL EVC that were inadvertently omitted from the previous filing. Rates were added in Transmittal No. 57. (Tariff F.C.C. Nos. 1, 2, 3, 6, 7, 8, and 9)
- (3) CenturyLink is adding eleven new special construction cases in its Tariff F.C.C. No. 12, Special Construction. Supporting information for these cases, discussed under Section 61.38 of the Commission's Rules, is included in the attached Special Construction Description and Justification (D&J).
