32. Contract Tariffs (Cont'd)32.27 Contract Tariff Option 50 (Cont'd)(D) Service Period

Subject to any early termination as set forth in Section M following, and the terms of Section C of this Agreement, the "Service Period" shall commence on the Effective Date and run for twenty four (24) consecutive months thereafter (the "Initial Service Period"). Following expiration of the Initial Service Period the parties may extend the Service Period for an additional twelve (12) months (the "Extended Service Period") upon mutual agreement.

Upon expiration of the Extended Service Period the Parties may, by mutual agreement, renew this Agreement for a second Service Period of twenty-four (24) months (the "Secondary Service Period"). Following expiration of the Secondary Service Period the parties may, upon their mutual agreement and option, extend the Secondary Service Period for twelve (12) months two times: once upon expiration of the Secondary Service term and once upon the One-year anniversary of the expiration of the Secondary Service Period.

(C)(E) Description of Contributory Services for Total Billed Revenue

Contributory Services included in the calculation of the Total Billed Revenue (TBR) amount (defined below) as used in Sections G and H following will be comprised of the following services:

The Monthly Recurring Charges for any Special Access Service as set forth in this Tariff as may be amended from time to time, and any Special Access Services provided under that Interim Master Services Agreement entered March 30, 2007, and assigned in part to FairPoint Communications effective as of March 31, 2008, as same may be amended from time to time (the "2007 IMSA"), and any services purchased by the Customer or its affiliates which Services are billed by FairPoint Communications or its affiliates under that Service Agreement dated February 16, 2011 (the "2011 Agreement") during the Term ("Contributory Services").

The TBR will include all MRCs for the Services that are billed under one of the USOCs in the following table and that are ordered by the Customer using one of the Customer ACNAs as agreed upon by the parties. Additionally, any additional USOCs used for forborne services provided under the 2007 IMSA and the 2011 Agreement are included in the calculation of TBR.
