7. Special Access Service (Cont'd)7.12 Ethernet Virtual Private Line (Cont'd)7.12.1 Basic Service Description (Cont'd)(C) Ethernet Virtual Private Line (EVPL) Channel Mileage

EVPL channel mileage charges apply to EVPL service based on the service speed and when the total distance associated with the data channel exceeds 45 miles between Telephone Company serving wire centers. EVPL channel mileage provides transport between two Telephone Company serving wire centers. Air mileage is measured using V&H coordinates between the Telephone Company serving wire centers. The EVPL channel mileage rate element will be applied on a per mile basis for each mile exceeding the first 45 miles of transport.
