Dear Secretary:

The accompanying tariff material, issued by Frontier Telephone Companies ("Frontier") and bearing FCC No. 7, FCC No. 11, and FCC No. 12, is scheduled to become effective October 25, 2014. This tariff material is sent to you for filing in compliance with the Communications Act of 1934, as amended. With this filing Frontier revises FCC No. 7 for an additional issuing carrier and issues new Tariffs FCC Nos. 11 and 12.

Frontier anticipates closing its acquisition of the local exchange and related business assets of AT&T, Inc. ("AT&T") in the state of Connecticut at midnight on October 24, 2014, taking ownership of these assets for the full day of October 25. To serve the customers in this purchased property, Frontier proposes to issue Frontier Telephone Companies Tariff FCC No. 11, replacing Southern New England Telephone Company Tariff FCC No. 39; to issue Frontier Telephone Companies Tariff FCC No. 12, replacing the material relevant to Connecticut in AT&T Operating Companies Tariff No. 1; and to incorporate material relating to Special Construction from Southern New England Telephone Company Tariff FCC No. 35 into Frontier Telephone Companies Tariff FCC No. 7.

The Frontier tariffs do not make any substantive changes to the content of the tariffs currently effective for the Southern New England Telephone Company. Included with this filing are side by side indexes cross referencing the new tariffs to the corresponding existing tariffs.

This filing relies on waivers of §§61.52(a), 61.54(b)(2), 61.54(c)(4), 61.54(i), 61.58, 61.59, and 61.74 of the Commission's rules and is made under authority of Special Permission No. 14-012.

In accordance with the Commission's fee filing requirements, a filing fee in the amount of nine hundred ten-dollars (\$910.00), has been paid by credit card and an electronic Form 159 has been submitted.
