Frontier Telephone Companies ("Frontier") hereby applies for a waiver of the requirements of Section 61.74 of the Federal Communications Commission's Rules. Frontier intends to introduce a new contract tariff option in its Tariff FCC No. 11 (FCC 11). The new contract tariff option provides discounted rates for certain Special Access services when the customer meets certain requirements. Discounts are only applied to services in areas where pricing flexibility has been granted for tariff FCC 11.

In order to implement the new contract tariff option, FCC 11 must make reference to Frontier's Tariffs FCC No. 1 (FCC 1), FCC No. 2 (FCC 2), Tariff FCC No. 3 (FCC 3), Tariff FCC No. 4 (FCC 4), Tariff FCC No. 5 (FCC 5), Tariff FCC No. 6 (FCC 6), and Tariff FCC No. 10 (FCC 10).

With this application, Frontier requests Special Permission to waive Section 61.74 of the Commission's rules in order to include the above mentioned tariff references in its proposed tariff filing. See the attached illustrative tariff pages bearing FCC No. 11 showing the proposed tariff references. Frontier relies on waiver of Section 61.59 to make changes to material not yet in effect, granted under Special Permission No. 14-012.

In accordance with the Commission's fee filing requirements, a filing fee in the amount of nine hundred ten dollars (\$910.00), has been paid by credit card and an electronic Form 159 has been submitted.
