With this filing, AT&T is proposing to remove The Southern New England Telephone Company (SNET) as an issuing carrier of AT&T Operating Companies Tariff F.C.C. No. 1 due to the sale of SNET, by AT&T, to Frontier Communications. This transaction will become effective on October 25, 2014. Regulations and rates pertaining to services offered in SNET are also being removed.
