This application is made by OLSEN THIELEN & Co., LTD (FRN 0004377529) on behalf of the following Issuing Carriers: Mankato Citizens Telephone Company, Mid-Communications, Inc and Heartland Telecommunications Company.

On January 1, 2015, the three issuing carriers wish to be removed from the NECA common line pools. This withdrawal will require these companies to cease participating in NECA Tariff FCC No. 5 effective Jan 1, 2015 and file their own access tariff rates, operating temporarily under the provisions of §61.39.

To accomplish this, OLSEN THIELEN & Co., LTD proposes to issue new tariffed rates in the End User Access Service section (these companies currently concur in NECA Tariff FCC No. 5). This tariff will continue to refer to NECA Tariff FCC No. 5 for certain regulation, terms, and conditions, but will contain rates specific to the issuing carriers

OLSEN THIELEN & Co., LTD requests waiver of §61.39 of the Commission's rules to temporarily operate under the §61.39 provisions without meeting the eligibility requirements in §61.39(a).

OLSEN THIELEN & Co., LTD also requests waiver of §69.3(e)(6) and §69.3(e)(11) to permit the companies to withdraw from the NECA pool on Jan 1, 2015 and file new tariffs without regard to the deadlines and requirements set forth in those paragraphs.
