

As part of this filing the CLOC also proposes to add six (6) cases in Tariff F.C.C. No.12, Special Construction. Supporting information for these cases, discussed under Section 61.38 of the Commission's Rules, is included in the attached Special Construction Description and Justifications (D&J). CLOC Tariff F.C.C. No. 3 also proposes some minor tariff language changes designed to clarify the state associated with the interstate access services.
