Dear Secretary:

The accompanying tariff material, issued by Frontier Telephone Companies ("Frontier") and bearing FCC No. 4, FCC No. 5, and FCC No. 6 is scheduled to become effective June 13, 2015. This tariff material is sent to you for filing in compliance with the Communications Act of 1934, as amended. With this filing Frontier removes National Discount Plan (NDP) from its tariffs.

NDP is closed to new customers, and currently has no customers. Frontier removes this plan to simplify its tariffs. Frontier also removes Contract Tariff Option 49 from FCC 4 and Contract Tariff Option 24 from FCC 5. These contract tariffs have no current subscribers, are closed to new subscribers, and have terms closely tied to NDP.

In accordance with the Commission's fee filing requirements, a filing fee in the amount of nine hundred ten-dollars (\$910.00), has been paid by credit card and an electronic Form 159 has been submitted.
