This filing is being made by Interstate Telcom Consulting, Inc. on behalf of: Granada Telephone Company and Pine Island Telephone Company.

On July 1, 2015, Granada Telephone Company and Pine Island Telephone Company will no longer be issuing carriers of the NECA F.C.C. No. 5 Tariff and will become issuing carriers of a new Interstate Telcom Consulting, Inc. F.C.C. Tariff No. 1.

Since the above mentioned telephone companies file their cost support pursuant to Section 61.39 of the Commission's rules, this new tariff will refer to NECA's Tariff F. C.C. No. 5 for its terms and conditions, but will contain rates specific to the above mentioned telephone companies.

Pursuant to §§61.151 through 61.153 of the Commission's rules, Interstate Telcom Consulting, Inc. requests special permission under which the Commission would grant a waiver, to the extent required, of §§61.52(b)(1), and 61.54(b)(2) of the Commission's rules in connection with the issuance of the new tariff.

Interstate Telcom Consulting, Inc. requests waiver of §61.52(b)(1) to permit it to place the name "Interstate Telcom Consulting, Inc." on each tariff sheet and waiver of §61.54(b)(2) to permit it to place the name "Interstate Telcom Consulting, Inc." on the title page of the tariff. Interstate Telcom Consulting, Inc. intends to include the exact legal names of the carrier covered by the Interstate Telcom Consulting, Inc. Tariff F.C.C. No. 1 Access Service Tariff in the "Issuing Carriers" section of the new tariff.
