
This filing proposes the following revisions to the CLOC tariffs as indicated:

1. Correct the Terminating Information Surcharge Rate that was incorrectly posted in Transmittal No. 72. (CLOC Tariff F.C.C. No. 3)
2. Add a new medium in which the Companies official access service bills and customer service records can be provided. Clarify language around secondary media if requesting multiple formats and add rates where they did not previously exist. (CLOC Tariff F.C.C. Nos. 1, 2, 3, 6, 7, 8 and 9)
3. Correct the footer that references the title of the Company Vice President. (CLOC Tariff F.C.C. No. 11)
4. Addition of 10 new special construction cases (CLOC Tariff F.C.C. No. 12)
