The CLOC is filing one new contract tariff in Section 24 of Tariff F.C.C. No. 9 and two new contract tariffs in Section 24 of Tariff F.C.C. No. 11. The CLOC is filing these contracts under authority granted in Section 69.727 of the Commission's Rules and is in compliance with terms contained in Section 61.55 of the Commission's Rules.

In addition, under authority of Special Permission No. 15-015, two of the DS1 and DS3 Price Flex Contracts (No. 15-002 and No. 15-005) require concurrent subscription to the CenturyLink Operating Companies Tariffs F.C.C. No. 9, Contract No. 15-002 and F.C.C. No. 11, Contract No. 15-005.

Per Section 61.58 these contracts are being filed on not less than one day's notice with an effective date of September 1, 2015.

As part of this filing the CLOC also proposes to add five (5) cases in Tariff F.C.C. No. 12, Special Construction. Supporting information for these cases, discussed under Section 61.38 of the Commission's Rules, is included in the attached Special Construction Description and Justifications (D&J).
