This contract is for renewal of 39 DS1s and 1 DS3 circuits purchased on a 12-month Pricing Plan. The monthly rates for the discounted circuits shall be billed at the rates set forth below. All other rate elements will be billed at the 12-month rates as set forth in Sections 7 and 17, preceding. Monthly rates for the entire 12-months will be frozen from Company-initiated rate changes and nonrecurring charges will not apply.

Total Monthly Rates for Discounted DS1 and DS3 Circuits:

- Monthly Recurring Rates \$5,690.96

The following eligibility criteria must be met in order to receive this Contract Offer:

- The customer must be renewing DS1 and DS3 circuits in Price Flex MSA wire centers in Phoenix-Mesa, Arizona, Des Moines, Iowa, Albuquerque, New Mexico, Portland-Vancouver, Oregon and Seattle-Bellevue-Everett, Washington.

The Company will waive the Termination Liability and Waiver Charges (TLA) for the DS1 and DS3 circuits disconnected prior to the expiration of the fixed period service rate plan so long as any such circuit being cancelled has been in service for at least 12 consecutive months at the time of cancellation.
