**2.7.3 (Cont'd.)**

to each long distance line and is calculated as follows:

Business Customers	\$ 3.97 per line per month	(I)
Centrex	\$ 1.62 per line per month	(I)
ISDN PRI	\$17.67 per interface* per month	(I)
Residential Customers	\$ 2.74 per line per month	(I)

The line determination is based on available Company and/or LEC-provided information. Where line charges cannot be determined by the underlying carrier, all line charges are \$3.97. (I)

The Federal Access Charge helps to defray the cost of access charges and fees that Local Exchange Carriers assess on interexchange carriers. This is a Company surcharge, not a tax, and is subject to change.

The Federal Access Charge will be billed at 50% of the applicable rate when the line is seasonally suspended.

\* The ISDN PRI charge is per pipe, not per channel.

The changes reflected on this revision will be implemented on a full bill period basis on the customer's January bill statement.
