RE: Special Permission Application No. 6

Consolidated Communications Companies, a holding company owning multiple incumbent local exchange carrier subsidiaries, would like to consolidate the interstate tariffs issued by its subsidiaries under a single filing entity.

To accomplish this, Consolidated Communications proposes to cancel the existing tariffs issued by its subsidiaries and, at the same time, issue three new tariffs under the name "Consolidated Communications Companies." Consolidated Communications Companies Tariff FCC No. 4 with issuing carrier Consolidated Communications of Illinois Company (CCIL) will replace Illinois Consolidated Telephone Company Tariff FCC No. 2. Consolidated Communications Companies Tariff FCC No. 6 with issuing carrier being Consolidated Communications of Illinois Company (CCIL) will replace Illinois Consolidated Telephone Company Tariff FCC No. 3, Special Construction. Consolidated Communications Companies Tariff FCC No. 5 with issuing carrier being Consolidated Communications of California Company (CCCA) will replace SureWest Telephone Tariff FCC No.1.

Pursuant to § 61.151 through 61.153 of the Commission's rules, and as discussed below, application is hereby made by the Consolidated Communications Companies, for Special Permission under which the Commission would grant a limited waiver, to the extent required, of §61.52(a)(1), 61.54(b)(2), 61.54(c)(4), 61.54(i), 61.59 and 61.74 of its rules in connection with Consolidated Communications issuance of new tariffs.

Consolidated Communications requests waiver of §61.52(a)(1) to permit it to place the name "Consolidated Communications Companies" on each tariff sheet and waiver of §61.54(b)(2) to permit it to place the name "Consolidated Communications Companies" on the title page of each tariff. Consolidated Communications intends to include the exact legal names of the issuing carriers covered by its tariffs within the Title page.



Consolidated Communications requests waivers of §61.54(c)(4) and 61.54(i) of the Commission's rules to permit Consolidated Communications to not use margin coding or other notations to show text changes, or moved material as would otherwise be required by these rules. All such changes will be non-substantive changes made to reflect organizational changes in the tariffs.

Consolidated Communications requests waiver of §61.59 of the Commission's rules so that it may make tariff filings affecting the Consolidated tariffs during the review period and for 30 days following the tariff's effective date. However, no filing made during the review period will have an effective date prior to the effective date of the new tariff. This waiver would permit Consolidated to make filings that would otherwise be permitted or required, but for the 30 day minimum effective period required by §61.59. At the time of our initial filing, we will file an updated USF at the same time but it will be a revision to the initial filing with a subsequent set of check sheets with the same effective date.

Finally, Consolidated requests waiver of §61.74 of the Commission's rules to permit it to continue to reference in the new tariff the same cross references to which the Commission has previously granted a waiver or waivers of this rule, and which are not currently allowed by §61.74.

Consolidated proposes no new material or substantive changes to content of its tariffs.

In accordance with Section 61.41, this application for special permission and associated attachments are being electronically filed today via the Federal Communications Commission's Electronic Tariff Filing System (ETFS) and payment in the amount of \$910.00 along with Form 159 are being transmitted electronically via ETFS simultaneous with this filing.
