This application is hereby made by Nevada Bell Telephone Company (NBTC) for Special Permission to waive Section 61.74 of the Commission's Rules in order to make references in NBTC Tariff F.C.C. No. 1, Access Service Offer, Contract Offer No. CCC, to the similar contract tariffs of the following AT&T Telephone Companies: Ameritech Operating Companies (Ameritech) Tariff F.C.C. No. 2, Contract Offer AAA; BellSouth Telecommunications, LLC (BellSouth) Tariff F.C.C. No. 1, Contract Offer BBB; Pacific Bell Telephone Company (PBTC) Tariff F.C.C. No. 1, Contract Offer No. DDD; and Southwestern Bell Telephone Company (SWBT) Tariff F.C.C. No. 73, Contract Offer No. EEE, as well as to make reference to Part 47 of the *Code of Federal Regulations*.

NBTC is proposing to offer a Special Access Service Offer (Contract Offer No. CCC), an access discount pricing plan which concurrent subscription is required to the above listed Access Tariffs.

With this application, NBTC requests permission to waive Section 61.74 of the Commission's Rules in order to include the above mentioned tariff references in its proposed contract tariff filing. Applications to waive Section 61.74 of the Commission's Rules are also being requested by Ameritech, BellSouth, PBTC and SWBT in separate filings.
