Dear Secretary:

TCA, Inc. (TCA) is a consulting firm which represents several rural Competitive Local Exchange Carriers (CLECs).

On October 23, 2015, TCA issued an interstate access tariff under its name with the CLECs participating in the tariff listed as Issuing Carriers to the tariff.

Pursuant to §§ 61.151 through 61.153 of the Commission's rules, after the fact and as discussed below, TCA requests a waiver of §§ 61.52 (a)(1) and 61.54 (b)(2) of its rules in connection with TCA's issuance of a consolidated tariff.

TCA requests waiver of § 61.52 (a)(1) of the Commission's rules to permit it to place the name "TCA, Inc." on each tariff page and waiver of § 61.54(b)(2) to permit it to place the name "TCA, Inc." on the title page of the tariff. TCA has included the exact legal names of the carriers covered by its tariff in the "Issuing Carriers" sections of the tariff.

A major interexchange carrier has stopped paying the switched access charges assessed by several of the issuing carriers listed below on the grounds that they did not have an interstate access tariff on file, and in our haste to file a tariff, TCA neglected to examine the FCC's rules carefully resulting in the need to submit this after-the-fact request for special permission.

In accordance with the Commission's fee filing requirements, a filing fee in the amount of \$910 dollars (\$910.00), has been paid by credit card and an electronic Form 159 has been submitted.
