With this filing, Micronesian Telecommunications Corporation is adding Universal Service Fund Charge language and surcharges in Section 6.14. The Contribution Factor reflected is in reference to the First Quarter 2016 Universal Service Contribution Factor in accordance with the Federal Communications Commission's *Public Notice*, DA-15-1412 (rel. December 11, 2015). This filing removes Universal Service Fund Charge language that was previously located in Section 12.4. This filing also adds Lifeline Service discount language in Section 11.6.

Supporting materials for tariff revisions increasing the First Quarter 2016 Universal Service Contribution Factor, as described under Section 61.38 of the Commission's Rules, are included with this filing.

In accordance with the filing requirements contained in Part 61.14(b) of the Commission's Rules, the aforementioned revised tariff pages are being filed electronically. Also in accordance with the Commission's filing requirements, required Form 159 and \$910.00 filing fee are being transmitted electronically today via the FCC's Electronic Tariff Filing System.
