## (H) Revenue Performance Credits

The Customer shall be eligible to receive Credits per quarter during the Service Period as set forth below and subject to the terms of this Agreement.

## (1) Calculation of TBR - Quarterly TBR Calculation:

- a. Other than Quarter 1 of Plan Year 1 for which quarterly TBR is calculated as set forth in (1) b. following, the TBR for a given Quarter during the Service Period shall be determined as follows: (i) determine the MRCs for the Contributory Services that are billed during such applicable Quarter; and (ii) subtract from the amount derived in (i) preceding any DS3 Credits that are earned during such applicable Quarter; and
- b. For Quarter 1 of Plan Year 1, the TBR shall be determined as follows: (i) determine the MRCs for the Contributory Services that are billed during Quarter 1 as well as during the period from June 1, 2011 to the Effective Date; and (ii) subtract from the amount derived in (i) preceding any DS3 Credits earned during Quarter 1 as well as during the period from June 1, 2011 to the Effective Date. The Parties agree that, notwithstanding the inclusion of MRCs and DS3 Credits in the calculation of quarterly TBR, the Services are provided pursuant to the terms of the applicable Tariff(s) and not pursuant to this Agreement or Contract Tariffs.

As used in Sections (H)(1)a. and b. preceding "earned" shall mean DS3 Credits that are associated with the MRCs for the Eligible DS3 Circuits that were billed during the applicable Quarter. The Parties acknowledge and agree, however, that the applicable DS3 Credit shall be provided on a CABS bill after the end of the applicable Quarter during which the MRCs for the Eligible DS3 Circuits were billed. In calculating TBR for the applicable Quarter, the Telephone Company shall only use DS3 Credits that are earned during such applicable Quarter.

Subject to the restrictions set forth in this Section 32.28, the calculation of the DS-0 Purchase Amount (as defined below) shall be determined by Customer and its affiliates' purchases of Qualifying Services in all Metropolitan Statistical Areas ("MSAs") and non-MSA areas within the states of Maine, New Hampshire and Vermont (including, for the avoidance of doubt, both Pricing Flexibility Relief Areas ("Price Flex MSAs") and all other areas in the Telephone Company operating territory).

F. Terms and Conditions(1) Qualifying Services

- a. Description of Qualifying Services. Qualifying Services included in the calculation of the DS-0 Purchase Amount and contributing toward the MADEC (both defined below) will be comprised of the following Services:

The DS-0 equivalents for any Switched or Special Access Services as set forth in this tariff, as the same may be amended from time to time, and any Switched or Special Access Services provided under that Master Services Agreement entered March 8, 2007, and adopted between the parties effective March 31, 2008, as same may be amended from time to time (the "2008 MSA"), and, any Ethernet E-Line Services provided under the 2008 MSA that were installed and commenced invoicing in the year 2015 or thereafter except as otherwise excluded pursuant to F(1)(c) following, which Services are billed by The Telephone Company during the Term ("Qualifying Services"); and
