2.21 Taxes, Surcharges and Other Miscellaneous Charges, (Cont'd.)

2.21.4 Carrier Cost Recovery Fee

The Carrier Cost Recovery Fee is intended to recover the Company's administrative costs associated with the FCC regulatory fees and programs, as well as other network and termination costs. This fee is assessed to all customers of services included in this tariff. For Customers who have selected the Company as their primary interexchange carrier, a Carrier Cost Recovery Fee in the amount of \$2.47 per ANI will be billed each month. For (I)
Customers who have not selected the Company as their primary interexchange carrier but access the Company's service via a CAC or dialing a toll free or local access number, a Carrier Cost Recovery Fee in the amount of \$2.47 per ANI will be billed in each month (I)
during which the Customer accesses the Company's services. For Customers who subscribe to the Company's local exchange services, a Carrier Cost Recovery Fee in the amount of \$2.47 per ANI will be billed in each month during which the Customer accesses (I)
the Company's interstate or international services.

For carrier-customers, the Carrier Cost Recovery Fee will not be applied to services sold by the Company to a Customer for resale for which the Customer has filed a Universal Service Worksheet, unless the Customer has a de minimus exemption which exempts the Customer from paying directly into the fund.

2.21.5 FCC Regulatory Fee (Wireline)

The FCC Regulatory Fee (Wireline) is intended to recover the costs associated with federal regulatory proceedings and compliance. This fee is based on a percentage of Customer's net interstate and international long distance usage during a month and will be equal to the annual assessment factor set by the Federal Communications Commission. This fee is assessed to all customers of service included in this tariff and only in months when there is applicable usage. This fee is not a tax or charge required by the government.

2.21.6 Federal Regulatory Compliance Fee

This fee will assist the Company in recovering the costs of administering, adhering to and filing expenses associated with regulatory proceedings and compliance. This fee will be applied on a per line basis to all Customers presubscribed to the Company's services. This fee is not a tax or charge required by the federal government.
