This filing proposes the following revisions to the CLOC tariffs as indicated:

1. Update the universal service contribution factors for the second quarter of 2016. This update applies the factor as adopted in Public Notice DA 16-266, released March 10, 2016. Supporting information for these rates is included in the attached USF Description and Justification (D&J). (CLOC Tariff F.C.C. Nos. 1, 2, 3, 6, 7, 8, 9 and 11).
2. Change late payment charge language and rates to mirror the rate posted in CLOC Tariff F.C.C. No. 11 to gain interest rate consistency between all CLOC tariffs. (CLOC Tariff F.C.C. Nos. 1, 2, 3, 6, 7, 8 and 9).
3. Change deposit language to mirror the late payment charge rates to gain interest rate consistency between all CLOC tariffs. (CLOC Tariff F.C.C. Nos. 2 and 3).
4. Remove obsolete Presubscribed Interexchange Carrier Charge (PICC) language in the Payment Arrangements and Credit Allowances – Payment of Rates, Charge and Deposits section. (CLOC Tariff F.C.C. No. 11).
5. Move the Shared Trunk Port and Dedicated Trunk Port language and rates to the Local Switching portion of the tariff. No rates have been changed. (CLOC Tariff F.C.C. No. 3).
6. Due to a billing system conversion and consolidation, references to “LATA” will be replaced with “state”. Customers will no longer need to report PIU/PVU factors by LATA. These factors will be applied at the state level under the new billing system. (CLOC Tariff F.C.C. No. 11).
7. Adding 27 new Special Construction cases in CLOC Tariff F.C.C. No. 12, Special Construction. Supporting information for these cases, discussed under Section 61.38 of the Commission’s Rules, is included in the attached Special Construction Description and Justifications (D&J)
8. Minor tariff language changes designed to clarify the provision of interstate service.
