This filing proposes the following revisions to the CLOC tariffs as indicated:

1. Display non-recurring rate elements (access order charge, service date change charge, design change charge, and miscellaneous service order charge) by switched and special elements. This change will allow CenturyLink to reduce the switched rate for these elements with Phase 5 of the ICC/USF Transformation Access reduction. Rates have not changed with this filing. (CLOC Tariff F.C.C. Nos. 1, 2, 3, 6, 7, 8 and 9).
2. Correct the End Office CLLI code for Lordstown, Ohio. (CLOC Tariff F.C.C. No. 9).
3. Update billing language to reflect the change in billing procedures that allow the customer to select either paper or electronic billing at no charge. (CLOC Tariff F.C.C. No. 11).
4. Adding 6 Special Construction cases in CLOC Tariff F.C.C. No. 12, Special Construction. Supporting information for these cases, discussed under Section 61.38 of the Commission's Rules, is included in the attached Special Construction Description and Justifications (D&J)
5. Minor tariff language changes designed to clarify the provision of interstate service.
