Dear Ms. Dortch:

Granite Telecommunications, LLC (“Granite”) submits to the Commission revised sheets 2 and 90.2, and original sheet 90.3 to Granite’s interstate Switched Exchange Access Services Tariff, FCC Tariff No. 1, for incorporation into the Company’s Tariff.

This submission is made pursuant to the Federal Communications Commission’s (“FCC”) *Report and Order and Further Notice of Proposed Rulemaking*, in Docket Nos. WC Docket No. 10-90, *et al.*, FCC 11-161,¹ *Second Order on Reconsideration* in Docket Nos. WC Docket No. 10-90, *et al.*, FCC 12-47,² and Sections 51.911 and 61.26(c)³ of the FCC’s rules, 47 C.F.R. §§51.911, 61.26(c).

Granite complies with the above cited orders and rules by setting its terminating switched access rates at parity with the corresponding incumbent local exchange terminating access rates in its service territory as set forth in the incumbent’s applicable interstate access tariffs effective on July 1, 2016 by citation, pursuant to Section 61.25(b) of the Commission’s rules, 47 CFR §§61.25(b).

If an ILEC to which a CLEC benchmarks its rates, pursuant to this section, lowers the rate to which a CLEC benchmarks, the CLEC must revise its rates to the lower level within 15 days of the effective date of the lowered ILEC rate.”
