The enclosed tariff, Tariff FCC No. 1 (Access), cancels and replaces in its entirety the Company’s FCC Tariff No. 1 (Access) currently on file with the Commission and is being filed to show a change in the Company name pursuant to Sec 61.171 of the Commission’s Rules, reflecting the Company name change from **tw telecom holdings inc.** to Level 3 Telecom Holdings, LLC. The regulations, rates, and charges contained in Level 3 Telecom Holdings, LLC’s FCC Tariff No. 1 are identical to those currently found in **tw telecom**’s Tariff No. 1, with the exception of minor textual changes necessary to reflect the revised page numbers and ensure consistent section headings and references.

The Company provides service to business customers only. The Company has changed its name to better align with their parent company, Level 3 Communications, LLC, under a unified brand and it will not affect any services or rates provided to customers of the Company. The following statement appeared on the invoices of all tw telecom customers in the March bill cycle: “Effective February 1, 2016, tw telecom holdings, llc and its subsidiaries have changed their name to Level 3 Telecom.”
