In accordance with the Commission's March 16, 2016 release entitled In the Matter of July 1, 2016 Annual Access Charge Tariff Filings, WC Docket No. 16-71, Order, DA 16-274, the instant filing includes proposed revised rates for the provision of the applicable End User, Special Access, Miscellaneous and Public Packet Data Network services offered by the issuing carriers filing pursuant to Section 61.38 in the JSI Tariff F.C.C. No. 1. Material required pursuant to In the Matter of Material to be Filed in Support of 2016 Annual Access Tariff Filings, WC Docket No. 16-71, DA 16-399 (released April 13, 2016) ("Tariff Review Plan Order") is included in this filing.

Existing Issuing Carriers

Accompanying this transmittal letter at Appendix B is a table listing the existing issuing carriers for JSI Tariff F.C.C. No. 1 which indicates the types of rate changes being made under this transmittal on behalf of each carrier. In addition to the required biennial filings for issuing carriers filing subject to Section 61.38 of the Commission's rules, all carriers

propose under this transmittal revised special access rates to reflect the reduced rate of return of 11.0 percent required by the Rate-of-Return Reform Order,¹ modified Access Recovery Charge (“ARC”) rates pursuant to § 51.917(e). Revised terminating End Office Access Service rates are proposed pursuant to § 51.909(f) where applicable (see Appendix B which identifies those carriers for which currently effective terminating End Office rates are under \$0.005 per minute and are therefore not filing revised End Office rates). Of the existing issuing carriers for JSI Tariff F.C.C. No. 1 who make mandatory filings in even-numbered years pursuant to Section 61.39 of the Commission’s rules, Mt. Horeb Telephone Company and Ellijay Telephone Company have elected to make mid-course voluntary annual filings.

New Issuing Carriers

Also accompanying this transmittal letter at Appendix C is a table listing carriers becoming issuing carriers for JSI Tariff F.C.C. No. 1 effective July 1, 2016. Of the nine carriers listed at Appendix C, eight are in the existing National Exchange Carrier Association (“NECA”) Traffic Sensitive Pool and are being canceled by NECA as issuing carriers for NECA Tariff F.C.C. No. 5 effective July 1, 2016 concurrent with the carriers becoming issuing carriers for JSI Tariff F.C.C. No. 1. Pioneer Telephone Association, Inc. d/b/a Pioneer Communications (“Pioneer”) will become an issuing carrier for JSI Tariff F.C.C. No. 1 concurrent with cancellation of Pioneer Tariff F.C.C. No. 1 effective July 1, 2016.

In this transmittal, JSI proposes, under Section 61.87(a) of the Commission’s rules, to cancel Pioneer Tariff F.C.C. No. 1 on behalf of Pioneer. Pursuant to Section 61.87(a), JSI is including with this Transmittal the revised Title Page for Pioneer Tariff FCC No. 1 with the required indication that the tariff is no longer effective.

As indicated at Appendix C, of the nine carriers becoming issuing carriers for JSI Tariff F.C.C. No. 1 under this transmittal, one carrier files rates on a prospective basis subject to Section 61.38. Supporting documentation accompanies this filing for this new carrier consistent with the requirements of the Tariff Review Plan Order mentioned above.

Removal of Egyptian Telephone Cooperative Association as Issuing Carrier

This filing also proposes to cancel the rates for the provision of Switched Access, Special Access and Miscellaneous Services offered by Egyptian Telephone Cooperative Association (“Egyptian”) as Issuing Carrier. Effective July 1, 2016, Egyptian will no longer provide interstate Switched Access, Special Access and Miscellaneous Services pursuant to the JSI Tariff F.C.C. No. 1. Instead, Switched Access, Special Access and Miscellaneous Services will be provided by Egyptian as an issuing carrier for NECA Tariff F.C.C. No. 5.

Federal Universal Service Contribution Factor – Knology of the Valley

Knology of the Valley, Inc. (“Knology”) is not a member of the National Exchange Carrier Association (“NECA”) Common Line Pool and therefore bills common line charges and related Federal Universal Service Charge (“FUSC”) charges pursuant to JSI Tariff FCC No. 1. All remaining issuing carriers for JSI Tariff FCC No. 1 are members of and participate in the NECA Common Line Pool and reference NECA Tariff FCC No. 5 with respect to FUSC rates. As the proposed third quarter 2016 FUSC factor of 17.9 percent reflects the currently effective rate, no revisions of the FUSC are proposed on behalf of Knology. See Proposed Third Quarter 2016 Universal Service Contribution Factor, CC Docket No. 96-45, Public Notice, DA 16-658 (released June 14, 2016).

Confidential Treatment of Rate-of-Return Tariff Review Plans

JSI seeks confidential treatment on behalf of the issuing carriers under the Tariff Streamlining Order² for certain supporting data contained in the required Rate-of-Return Tariff Review Plans (“TRPs”). Confidential TRPs bear on each worksheet “CONTAINS PRIVILEGED AND CONFIDENTIAL INFORMATION – DO NOT RELEASE”, and redacted versions of the TRPs are also submitted.
