By this letter and attached tariff sheets, Zayo Group, LLC ("Zayo") withdraws and cancels in its entirety its Switched Access Service Tariff, bearing the designation F.C.C. Tariff No. 1. Currently, Zayo does not provide or offer switched access service and has no plans to do so in the future. Therefore, Zayo no longer needs to maintain this tariff. Should Zayo decide to offer or provide switched access service in the future, Zayo will submit a new tariff.
