**7.1.3 Local Switching****Local Switching**

Local switching provides local end office switching and end user termination functions necessary to complete the transmission of switched access communications to and from the end users served by the local end office.

Rates apply to all access minutes that originate from or terminate to the Telephone Company's end office (equal access). Rates are intended to mirror the ILEC's tariffed rates for the serving area. The rates below apply to calls in the service areas of the listed ILEC.

The Shared End Office Trunk Port provides for the termination of a Tandem-Switched Trunk at an end office. The Shared End Office Trunk Port is usage rated and shall be assessed on all access minutes that utilize Tandem-Switched Transport.

When Tandem-Switched Transport is provided by more than one company, the Shared End Office Trunk port charge shall be billed by the Company in whose territory the end office is located.
