The Access Recovery Charge (ARC) is a monthly charge authorized by the FCC as part of its Intercarrier Compensation (ICC) Reform initiative. The ARC is designed to recover increased network costs for access circuits used to provide service to customers. For CTC resale customers, the ARC will be equivalent to the ARC charged by the applicable incumbent local exchange carrier.
