**SECTION 2 - RULES AND REGULATIONS, (CONT'D)****2.11 Termination of Access Service (cont'd)****2.11.1 Customer Termination of Service (cont'd)****2.11.1.C Access Service Termination Procedures**

In order to comply with the Company's Access Service Termination Procedures, the Customer must fulfill certain obligations, including, but not limited to the following:

2.11.1.C.1 The Customer must provide for alternate routing of all access traffic originating from and/or terminating to the Shared Customer; (C)

2.11.1.C.2 The Customer must notify the Company of its intention to cancel access service arrangements with the Company in the requisite timeframe set forth in Sections 2.12.2.A. and 2.12.2.B., and in such format and including such information as determined and required by the Company. Any such termination notice provided by the Customer must be stated in reasonably explicit and unequivocal terms. No request for termination will be accepted by the Company where the termination notice is equivocal or where the Customer acts in a manner inconsistent with the termination notice. Such acts include, but are not limited to, the following:

2.11.1.C.2.(a) Continued acceptance by the Customer of the Company's switched access traffic;

2.11.1.C.2.(b) Entering into new negotiations with the Company;

2.11.1.C.2.(c) Failure to specify the exact service to be cancelled;

2.11.1.C.2.(d) Failure to block the Company's switched access traffic in accordance with the procedures set forth herein;
