SECTION 2- REGULATIONS, Continued2.10 Application of Rates (cont'd)2.10.4 Territory

The applicability of particular rates is based on the locations (including any applicable zones) to or from which the Company provides Access Service. Such locations and zones are determined without reference to the physical locations of End Users, but, instead, are determined by reference to the locations of the Rate Centers that are associated, according to the LERG (The LERG ["Local Exchange Routing Guide"]) may be obtained from: Telcordia Technologies, Customer Services Division, 60 New England Avenue, Piscataway, NJ.) with the Central Office Codes of the telephone numbers used by or assigned to the involved End Users in connection with the Interexchange Communications for which the Company is providing Access Service. The rates that will be applied by the Company to Access Service provided for a particular location are determined by reference to the incumbent local exchange carrier ("ILEC") that serves the location (and the zones) as set forth in the National Exchange Carrier Tariff FCC No. 4 (the "NECA Tariff"). As used herein for such purpose:

"AT&T CA" refers to locations served by Pacific Bell Telephone Company in California;

"AT&T NV" refers to locations served by Nevada Bell Telephone Company in Nevada;

"Centel" refers to locations served by Central Telephone Company in Nevada

"Citizens CA" refers to locations served by Citizens Telecommunications Company of California in California; (T)

"Citizens NV" refers to locations served by Citizens Telecommunications Company of Nevada in Nevada; (T)

"Frontier SW" refers to locations served by Frontier Communications of the Southwest, Inc. in Nevada;

"ConCom" refers to locations served by Consolidated Communications of California Company; (T)

"Frontier CA" refers to locations served by Frontier California Inc. in California; (T);
