

2. Discontinue wholesale interstate Busy Line Verification (BLV) and Busy Line Interrupt (BLI) effective October 1, 2016 under authority granted pursuant to Section 214 of the Communications Act and Section 63.71 of the Commission's rules. (CLOC Tariff F.C.C. Nos. 2, 3, 9, and 11).
3. Minor tariff language changes designed to clarify the provision of interstate service including:
 - Clarification of service credits (CLOC Tariff F.C.C. Nos. 1, 2, 3, 6, 7, 8 and 9)
 - ARC Centrex exemption clarification (CLOC Tariff F.C.C. Nos. 1, 2, 3, 6, 7, 8 and 9)
 - Removal of USOC's and Field Identifiers (CLOC Tariff F.C.C. Nos. 2, 3, 8 and 11) as part of the consolidation and alignment of CenturyLink's billing system and tariffs.
4. Adding two (2) new cases in Tariff F.C.C. No.12, Special Construction. Supporting information for these cases, discussed under Section 61.38 of the Commission's Rules, is included in the attached Special Construction Description and Justifications (D&J).
