This application for special permission requests waiver of the requirements of Section 61.74 of the Federal Communication Commission's Rules in order to make reference in CenturyLink Operating Companies Tariff F.C.C. No. 9 Section 24, Contract No. 16-002, to the similar contract tariff of CenturyLink Operating Companies Tariff F.C.C. No. 11, Contract No. 16-004.

Application is also being made on behalf of Qwest Corporation d/b/a CenturyLink QC for Special Permission to waive the requirements of Section 61.74 of the Commission's rules in order to make reference in CenturyLink Operating Companies Tariff F.C.C. No. 11 Section 24, Contract No. 16-004 to the similar Contract Tariff of CenturyLink Operating Companies Tariff F.C.C. No. 9, Contract No. 16-002.
