Streamlined Filing

This Streamlined filing is **being** made on 15 days' notice in accordance with Section 204 (a)(3) of the Communications Act.

This filing proposes the following revisions to the CLOC tariffs as indicated:

1. Standardize tariff language contained in CenturyLink interstate access tariffs associated with the cancellation of customer orders. When the customer initiates a request for the installation of service and fails to respond to company inquiries within 30 days after the original service date, the tariff language does not clearly define the process for customer-delayed orders. Current company processes differ by legacy company (Qwest, Embarq and CenturyTel) on when billing begins and when the orders should be cancelled and there is strong desire to standardize company processes. Accordingly, standardization is required in the Service Date Change language to revise the number of days that existing service orders can be delayed to 60 calendar days. (CLOC Tariff F.C.C. Nos. 1, 2, 3, 6, 7, 8, 9 and 11).
2. Update and clarify the Lifeline Assistance Program language per the FCC Lifeline Broadband Order, FCC 16-38. (CLOC Tariff F.C.C. Nos. 1, 2, 3, 6, 7, 8, 9 and 11).
3. Update the diagrams for Switched Access categories of service (Section 6.1.3). (CLOC Tariff F.C.C. Nos. 1 and 8).
4. Adding 3 Special Construction cases in CLOC Tariff F.C.C. No. 12, Special Construction. Supporting information for these cases, discussed under Section 61.38 of the Commission's Rules, is included in the attached Special Construction Description and Justifications (D&J)
5. Minor tariff language changes designed to clarify the provision of interstate service.

In accordance with the requirements of Section 61.15(a)(4) of the Commission's Rules, the FCC Registration Number (FRN) for CenturyLink is 0018-6268-53. CenturyLink is filing this transmittal on behalf of issuing carriers on Attachment A.
